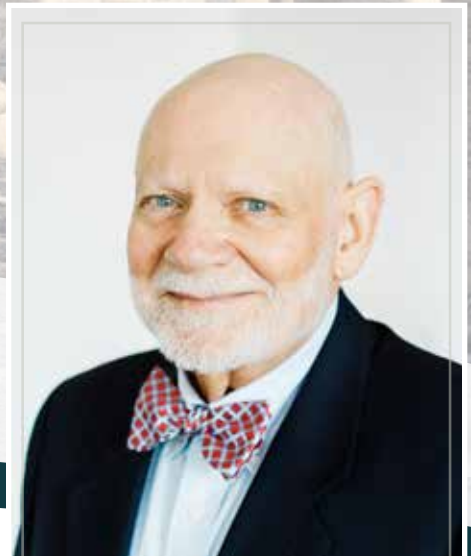
Leon received his undergraduate degree (B.M.) from DePauw University and his master's degree from Miami University. He received his law degree (J.D.) from Capital University.
