He also served as Interim Solicitor for the Village of Alexandria for two years, providing similar legal services.

As Granville Law Director and Prosecutor, Michael compiled a significant



track record of success and contributions to the community. He helped place a permanent conservation easement on the historic Granville Golf Course to ensure that the treasured local resource will remain undeveloped and green for future generations. Michael helped to revise and update the zoning code to guide sustainable development. He negotiated and drafted agreements that facilitated the construction of a new Granville service department complex and a new Granville Township fire station. Michael frequently worked with community stakeholders such as Denison University, Grow Licking County, The Granville Township Board of Trustees, and the Granville Chamber of Commerce, keeping his finger on the community's pulse to better anticipate and meet its legal needs. He also helped select the Granville Chief of Police and the Denison University Safety Director, fostering a community policing model that builds strong, respectful, and collaborative public safety protocols.
