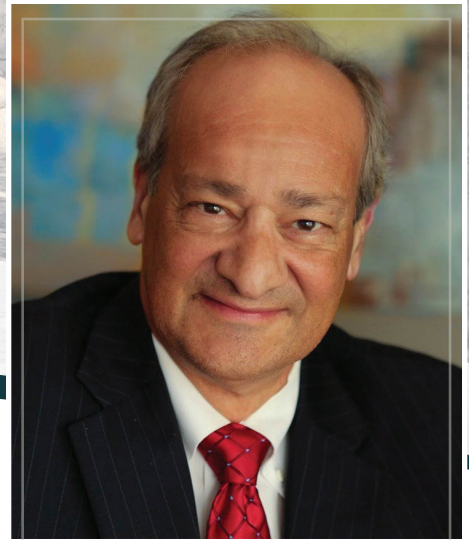
Alan received his Bachelor of Science in Accountancy from the University of Illinois in 1974 and his law degree from Chicago-Kent College of Law in 1977.

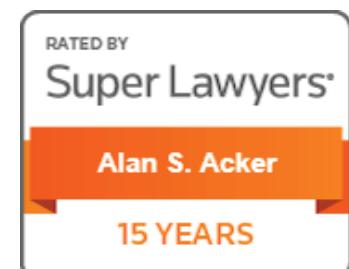
